

\$0 FUNDING FEES TERMS AND CONDITIONS





▶ 1. The '\$0 Funding Fees' promotion (hereinafter - Promotion) offered is valid for deposits made via all payment methods available at FXGrow.

2. By enrolling in this offer, client acknowledges that S/He has read and agreed to be bound by these terms and conditions as well as by FXGrow Trading Terms and Conditions.

3. The Promotional Period specifically for this Offer shall run for Indefinite period.

4. The Promotion is available for registered and fully verified Clients only.

5. During the Promotion period the Company will refund all transaction fees in a form of Trading Credit.

6. The Transaction Fees will be credited (Trading Credit) into the eligible client's account, as a notional sum, after all requirements set out in these terms and conditions have been met.

7. The Trading Credit will not be recorded or construed as a liability of FXGrow towards the clients and may be unilaterally, retroactively and unconditionally be withheld and subtracted from the client's account, at any time and at the discretion of FXGrow.

8. The 'Trading Credit' may be used for trading purposes and cannot be withdrawn without meeting the criteria below:

- For each \$2 in Trading Credit (or its equivalence in any other currency); Client must trade 1 Standard Lot (FX pairs & Metals).

9. Trading Credit will be converted to withdraw-able cash if the client reached the number of traded lots per each \$2 (or its equivalence) in Trading Credit.

10. Any withdrawal of funds will nullify all previously granted Trading Credit unless the required number of traded lots against conferred Trading Credit is meet.

FXGrow reserves the right at its sole discretion, to decline registration of any applicant in the Promotion without any justifications and the right to disqualify any applicant in the Promotion who interfers with the process of the Promotion, or breaches its terms and/or any of the "FXGrow Terms and Conditions' set forth on FXGrow website/Secure Area.
