TRADE BACK PROMOTION

TERMS AND CONDITIONS



1. The 'TradeBack Promotion' (hereinafter - Promotion) is valid for registered and fully verified Clients who were not referred by any of FxGrow partners, affiliates or IBs, and applies to ECN and ECN Plus accounts and it is limited to one trading account per client (regardless of the number of accounts which the client maintain with FxGrow.)
2. By opening a trading account during the term of the Promotion, the Client acknowledges that he has read and agreed to be bound by these terms and conditions as well as by FxGrow Trading Terms and Conditions.
3. In order to participate in this Promotion the Client must send a request to offers@fxgrow.com to be enrolled in the Promotion within the first 5 business days from the date of the deposit date. If the Client starts trading before he requests to be enrolled, the Client will not be entitled to the Promotion and it is on Company's discretion to grant enroll the client in the promotion after the expiry of the 5 business day's limit.
4. Rebates will be calculated on monthly basis according to the following:
