► **Terms & Conditions of the 100% Welcome Margin Bonus- exclusive offer for SignalTrader subscribers**

- 1- The “100% Welcome Margin Bonus” promotion (Hereinafter- Promotion) is applicable only for fully verified Clients at FxGrow and who subscribed to services provided by SignalTrader.
- 2- By registering Profile and opening a trading account during the term of the “Promotion”, the Client acknowledges that s/he has read and agreed to be bound by these Terms and Conditions as well as by ‘FxGrow’ Trading Terms and Conditions.
- 3- The “Promotion” is limited to **one (1) SignalTrader trading account in USD per Client only.**
- 4- The Marginal Bonus is applicable for **First Deposit only.**
- 5- Internal transfers are not eligible for the Margin Bonus.
- 6- The maximum amount of Marginal bonus is capped at 5,000 USD per client.
- 7- The “Promotion” offer is valid **from 04/07/2016 until 30/09/2016** inclusive of these dates.
- 8- Margin Bonus expiry date is 30/09/2016 at 23:59 GMT+3.
- 9- Trading accounts registered under the ‘Promotion’ are denominated in **U.S Dollars Only.**
- 10- The Marginal Bonus cannot be withdrawn or transferred between accounts.
- 11- The marginal bonus is automatically credited to the client live trading account and reflected in the ‘Credit’ section.
- 12- Client will be rebated 1 USD per each concluded lot FX currency pairs and precious metals.
- 13- The 1 USD rebate will be debited automatically to client live trading account and reflected in the ‘Balance’ section, the exact amount will be removed and reflected in the ‘Credit’ section simultaneously after each concluded lot.
- 14- 1 USD Rebate is only applicable for FX pairs and precious metals trades.

- 17- Margin Bonus can be converted to cash, **1 USD per Concluded Lot.**
- 18- This Promotion is subject to all FxGrow Terms and Conditions.
- 19- FxGrow has the right, at its sole discretion, change the present Terms and Conditions or Cancel the ‘Promotion’ at any time without prior notice.

- 21- Stop Out Level is set at 60% Free Margin: Free Margin Equation: **Equity / Margin.**



- 22- Equity= **Credit + Balance (+ or -) unrealized profit/loss**
- 23- If Stop Out **Level (60%) was below Margin Credit Level**, once account losses reaches Credited amount, Credit will automatically be removed and positions will be stopped out.
- 24- Credit offered under the Terms and Conditions of the promotion can be used only as leverage, and cannot be lost, transferred between accounts or withdrawn. The Margin Credited can be converted to Cash.
