The undersigned (hereinafter the “Client”) hereby grants permission to link his/her Growell Capital Ltd (with brand name: FxGrow) trading account with Triple A Experts Investment Services SA. and use the services provided by Triple A Experts Investment Services SA, (hereby called ‘ZuluTrade’), pursuant to the Limited Power of Attorney granted by the Client to ZuluTrade whereby the Client authorises ZuluTrade to manage his/her account with Growell Capital Ltd (“Managed Account”) as per the provisions of the Limited Power of Attorney.

The Client agrees to the following conditions:

1. That Growell Capital Ltd has made no representation regarding the potential profitability of the ZuluTrade service.
2. That client is fully aware of the risk involved in trading in the foreign exchange market, and that Growell Capital Ltd holds no liability for any losses to client’s account caused by mechanical, software, communication failure, system error or any other causes beyond its immediate control.
3. That Growell Capital Ltd shall execute the signals generated by the ZuluTrade as delivered to Growell Capital Ltd and that Growell Capital Ltd takes no responsibility for advising the client of any changes, alterations, enhancements or optimisations made by ZuluTrade.
4. That ZuluTrade is not permitted to make a deposit or withdrawal of funds into or from the client’s account. Only the owner of the trading account has the right to deposit and withdraw funds from the trading account.
5. In consideration for my use of the ZuluTrade services, I authorise and instruct Growell Capital Ltd to pay a spread fee of 1 pip per lot to ZuluTrade. Such spread fee is not an extra fee charges to me but it is incorporated in the spread between the bid/ask prices offered to me by Growell Capital Ltd.
6. That this LOD shall remain valid until revoked in writing by the client.



LIMITATION OF LIABILITY

You understand that in no event will Growell Capital Ltd or its officers, directors, shareholders, parents, subsidiaries, affiliates, employees, agents, licensors or any data provider be liable for any consequential, punitive, incidental, special or indirect damages, loss of business revenue or lost profits arising as result of your use of the Managed Account or through the acts or omissions of the account manager, whether in an action under contract, negligence or any other theory, even if Growell Capital Ltd is advised of the possibility of such.

By signing you hereby agree to indemnify, defend and hold harmless Growell Capital Ltd and its officers, directors, shareholders, parents, subsidiaries, affiliates, employees, plan sponsors, consultants, agents and licensors from and against any and all third-party claims, liability, damages and/or costs (including, but not limited to, reasonable attorney's fees) arising from your use of a ZuluTrade account, including without limitation, any failure to comply with the terms and conditions of Growell Capital Ltd websites, or other right of a third party, or from a violation of applicable law.
